WELDON REGIONAL WATER DISTICT APPROVAL EXTENSION (Agenda Item 8d)

The Executive Officer informed the Commission that the formation of the Weldon Regional Water District was approved by this Commission on April 29, 2020 contingent upon election results. Due to several delays, a formation election and board of directors' election have not been held. As per Section "L" of the Kern LAFCo Procedures, Standards, and Policies for the Evaluation of Proposals, all proposals are to be finished within a year or an extension up to 90 days is required. Due to current pandemic schedules and procedural delays, Mr. Knox recommended that the Commission approve a one-year extension to expire LAFCKC 3/24/21 68-7

## CALIFORNIA LEGISLATIVE REPORT (Agenda Item 8f)

The State Legislature introduces numerous bills before the February deadline every year. Some of the bills are repeats of bills that died last year when the legislature narrowed focus to those pertaining to COVID, fire and education. Many of the new bills will focus on the Brown Act meeting requirements once the pandemic allows for in person meetings. Additionally, bills targeting specific districts or areas will be introduced. Mr. Knox continues to serve as vice-chair of the Legislative Committee at CALAFCO and will update the Commission as necessary.

## INDEMNIFICATION LITIGATION: (Agenda Item 8g)

Mr. Knox informed the Commission of the lawsuit between San Luis Obispo Local Agency Formation Commission versus the City of Pismo Beach. The lawsuit went to the Second District Court of Appeal regarding indemnification agreements. The court ruled the Cortese-Knox-Hertzberg Act does not authorize LAFCO to require indemnification agreements to indemnify against suits from the applicant. The Kern LAFCO indemnification agreement only indemnifies from third party suits. The standard indemnification agreement used by Kern LAFCO is enforceable and not affected by this case.
